The Borrower (Zagrebački Holding d.o.o. - ZGH) has applied for financing in the amount of up to EUR 56 million from the International Finance Corporation (IFC) toward the cost of the ZGH Green Loan project, and it intends to apply part of the proceeds to payments for goods and non-consulting services to be procured under this project.

The project will include the following components:

Component 1: Specialized Vehicles for Municipal Waste Collection and Cleaning Vehicles
Component 2: Biowaste Collection Vehicles and Pre-Treatment Equipment
Component 3: Construction Waste Collection and Roads Reconstruction Vehicles and Machinery
Component 4: ICT Infrastructure
Component 5: Other Auxiliary Machinery

The following contracts are planned to be procured through open international competitive procurement:

- Tender No. 1 - Delivery and heavy-duty vehicles for municipal, construction, biowaste and other materials collection and transportation (vehicle with platform, road maintenance vehicles, service vehicle, patrol vehicle, cargo trucks, fuel tanker, water tanker, workshop service van, auto – platform with large crane, auto – platform with small crane, large grabber, small grabber, trucks 18/26 tons, etc.). Tender will be divided into LOT-s.
- Tender No. 2 - Special-purpose vehicles for municipal waste collection and cleaning (vehicles for waste collection, various recycling trucks, garbage trucks, vehicles for street washing and cleaning, road washing vehicles). Tender will be divided into LOT-s.
- Tender No. 3 - Work machinery and equipment (grader, mini excavators, mini loaders, backhoes, mini pavers, rollers, vibration plates and tampers, asphalt and concrete cutters, hand cutters for concrete, removal machines for horizontal markings, mini combined machine, mini excavators, loader, tractor attachments, impact hammer, motorized post hole digger with augers). Tender will be divided into LOT-s.
- Tender No. 4 – IT package for procurement of the unified and centralized system for invoicing, calculation, collection and management of various fees,

contributions, utility and other services. The very first phase of the project would cover 4 business process owners (business process owners covers entities that are providing utility services to the end users). This system shall be on-prem solution.

Procurement of contracts financed by the IFC will be conducted through the procedures as specified in the World Bank's *Procurement Regulations for IPF Borrowers (September 2023) (Procurement Regulations)* and is open to all eligible firms and individuals as defined in the *Procurement Regulations*.
